Subject: Agenda item 5 – Overview of statutory authority of the Committee

Recommendation: This agenda item requires no action from the Committee.

Background

The Texas State Veterans Cemetery Committee ("Committee") was created by the Texas Legislature in 2001. The Committee is composed of the three members of the Veterans Land Board ("VLB"), the Chairwoman of the Texas Veterans Commission, and two representatives of the State's veterans' community. The creation of the Committee pre-dates the establishment of the first Texas State Veterans Cemetery ("Cemetery").

Pursuant to the Texas Natural Resources Code ("Code"), §164.005(f), the Committee establishes guidelines for the location and size of Texas State Veterans Cemeteries and eligibility requirements for burial in them and selects up to seven locations for them. The Committee meets as necessary at the call of the chair.

Site Selection Criteria and Considerations

Site selection is governed by several factors.

1. Land must be donated to the State of Texas. The Code, §164.005(h), precludes the VLB from using funds from the Veterans Land Fund and the Housing Assistance Funds to "acquire land to be used for a veterans cemetery."

2. The VLB must have sufficient funds to operate and maintain the cemetery. The VLB must have sufficient funds to support perpetual care and operations and maintenance at the Cemeteries. The Code, § 164.005(h), caps expenditures to operate Cemeteries at \$7 million per fiscal year. The \$7 million cap is not adjusted for inflation.
3. The National Cemetery Administration must provide grant funding to establish or expand a cemetery. The National Cemetery Administration (NCA), a division of the U.S. Department of Veterans Affairs funds the establishment and expansion of state cemeteries through grants. ^{(b)(1)} The NCA funds 100% of the costs for establishing or expanding the Cemeteries. The VLB employs a grant writer to assist in grant applications. The VLB does not fund the establishment or expansion of the Cemeteries.
4. The NCA uses specific criteria to make grant funding decisions. Funding decisions for grants and site selection by the NCA include:
 - a. Ensuring there is no significant overlap in service between existing national or state cemeteries;
 - b. Ensuring there is a utilization rate that is consistently above the national average;
 - c. Maintaining an average of 50 or more interments per year for a cemetery;
 - d. Ensuring there is available land to support a new cemetery or expand an existing cemetery;
 - e. Evaluating of the number of the unserved veteran population. An unserved Veteran is defined as one who lives more than 75 miles from a national or state VA grant-funded state cemetery; and
 - f. Having available funds appropriated by the U.S. Congress.

The effect of the combination of state law, VLB funding, and federal NCA laws and regulations is that the VLB is dependent on donations of land. A selected location must be sufficient to operate as an active cemetery accepting interments for a minimum of 20 years. It must be in an area that is not serviced by an existing state or national cemetery and will have a sufficient number of unserved Veterans in the area. Because the VLB does not fund the establishment or expansion of Cemeteries, if a potential location does not meet the NCA criteria, the VLB will not be eligible for federal funding.

Burial Eligibility Criteria and Considerations

As mentioned, the Code, § 164.005(f), states that the Committee shall establish guidelines for the “eligibility for burial in a veterans cemetery.” The eligibility rules for the Cemeteries mirror those of

U.S. Department of Veterans Affairs (VA) National Cemeteries. The NCA reimburses the VLB a plot allowance of \$893.00 per eligible interment. States have limited flexibility to amend eligibility, but certain state-level changes to burial services are not reimbursed by the NCA. For example, under NCA rules, spouses of Veterans are eligible for burial, but the NCA does not reimburse the VLB for that plot allowance. As a benefit to Texas Veterans and their families the VLB provides this benefit at no cost to the spouse. Some states charge for spouses to be interred in their state veteran cemeteries. Burial benefits include military honors, grave plots, opening and closing of graves, headstones or markers, burial flags, and perpetual care of the graves.

Current eligibility for burial includes:

1. **Honorably Discharged Veterans and Active Duty Service Members:** Veterans who were honorably discharged from the U.S. Armed Forces, including active duty service members who die while on duty, are eligible.
2. **Reserve Components and ROTC Members:** Certain members of reserve components and Reserve Officer Training Corps (ROTC) qualify.
3. **National Guard Members:** Eligibility extends to retired National Guard members.
4. **Commissioned Officers of NOAA and U.S. Public Health Service:** Certain commissioned officers of the National Oceanic and Atmospheric Administration (NOAA) and the U.S. Public Health Service are eligible.
5. **World War II Merchant Marines:** Qualifying World War II Merchant Marines are eligible.
6. **Philippines Armed Forces Members:** Certain members of the Philippines Armed Forces may qualify.
7. **Spouses and Dependents:** Spouses and certain of Veterans dependents are also eligible.

Subject: Agenda item 6 - Consideration and possible action on guidelines related to the location and size of veteran cemeteries and eligibility for burial in veteran cemeteries.

Recommendation: Staff recommends the Committee establish the proposed Guidelines in accordance with Chapter 164 of the Texas Natural Resources Code §164.005 (f) (1) (b) & (b).

Background: The Texas Natural Resources Code (Code), §164.005 (f) (1), states that the Texas State Veterans Cemetery Committee (Committee) shall establish the guidelines for determining: (A) the location and size of veterans cemeteries; and (B) the eligibility for burial in a veterans cemetery."

Staff conducted a search of records in the custody of the Texas Veterans Land Board (VLB) and the Texas General Land Office (GLO) and is unable to determine if the Committee ever established these guidelines. This agenda item is intended to ensure that the Committee establishes the guidelines so that staff may carry out its duties in accordance with the law.

The proposed guidelines ensure that all decisions related to the location and size of cemeteries and the eligibility for burial comply with state law and the National Cemetery Administration's laws and regulations.

The Code, §164.005 (f)(2), states that the Committee must, "select up to seven locations across the state for veterans cemeteries." The proposed Guidelines accompanying this memo do not pertain to this duty. Site selection is determined through a vote of the Committee.

GUIDELINES FOR TEXAS STATE VETERANS CEMETERIES

1. **REASON FOR ISSUE:** These Guidelines provide for the determination of the location and size of Texas State Veterans Cemeteries (Cemeteries) and the eligibility for burial in them. These Guidelines supersede any previous guidelines pertaining to these duties of the Texas State Veterans Cemetery Committee (Committee).
2. **SUMMARY OF CONTENTS:**
 - a. Guidelines for determining the location and size of Cemeteries.
 - b. Guidelines for determining the eligibility for burial in a Cemetery.
3. **PURPOSE/AUTHORITY:**
 - a. These Guidelines are established in accordance with the Texas Natural Resources Code (Code) §164.005(f)(1).
4. **BACKGROUND:**
 - a. The Code, §164.005 (f) (1), states that the Committee shall, “establish the guidelines for determining: (A) the location and size of a veterans cemetery; and (B) the eligibility for burial in a veterans cemetery.”
5. **GUIDELINES:**
 - a. Guidelines for determining the location and size of the Cemeteries.
 - i. The Veterans Land Board (VLB) shall follow state law regarding solicitation and acceptance of donations of land for the purpose of establishing and expanding the Cemeteries.
 - ii. The VLB shall determine if any potential donation of land is in the best interest of the Texas State Veterans Cemetery Program. Factors here may include, but are not limited to:
 - a. Potential eligibility of the location and size to receive federal grants from the National Cemetery Administration (NCA).
 - b. Any relevant guidance provided by the NCA.
 - c. Environmental considerations.
 - d. Zoning designations.

- e. The ability of the VLB to fund maintenance and operations and perpetual care based upon projected expenses and available funds; and
 - f. Community support.
- iii. The Committee reserves the authority to select the location of seven Cemeteries across the state.
- b. Guidelines for determining the eligibility for burial in a Cemetery.
 - i. The VLB shall ensure that individuals eligible for burial under the NCA are eligible for burial in Cemeteries.
 - ii. The VLB may vote to extend burial eligibility to individuals not provided for in NCA laws and regulations if such eligibility does not violate state law or NCA laws and regulations, or if such eligibility does not jeopardize future NCA grant funding or burial allowances from the NCA.
 - iii. The VLB is responsible for conducting all rule making and publication of proposed and final rules in the Texas Register.

Subject: Agenda item 7 – Consideration and possible action to designate 100 acres in Lubbock as the location of the fifth Texas State Veterans Cemetery.

Recommendation: Staff recommends the Texas State Veterans Cemetery Committee designate 100 acres in the City of Lubbock as the site of the West Texas State Veterans Cemetery.

Background

The Texas Natural Resources Code, §164.005(f)(2) gives the Texas State Cemetery Committee the authority to, "select up to seven locations across the state for veterans cemeteries."

As of June 24, 2024, the Veterans Land Board (VLB) operates four Texas State Veterans Cemeteries to include:

- Central Texas State Veterans Cemetery in Killeen
- Texas State Veterans Cemetery at Abilene
- Coastal Bend Texas State Veterans Cemetery in Corpus Christi
- Rio Grande Valley Texas State Cemetery in Mission

In May 2022, the City of Lubbock unanimously approved a donation of 100 acres to the Texas General Land Office (GLO) and the VLB to establish a State Veterans Cemetery. Based on National Cemetery Administration (NCA) guidance and an examination of the unserved Veteran population, VLB staff prepared a grant application for a medium size cemetery.

On June 28, 2022, the VLB applied for a cemetery establishment grant from the NCA.

On October 1, 2022, the NCA notified the VLB that the grant application was not awarded due to insufficient federal funds.

In January 2023, the NCA informed the VLB that limited funds were available for the proposed Lubbock grant. The NCA directed the VLB to modify the initial grant application to reduce the dollar amount requested. VLB staff executed a scope reduction and submitted the revised grant application to the NCA.

On February 23, 2023, the NCA awarded an establishment grant of \$15.9 million for the Cemetery. The GLO approved an additional \$638,400 to cover the reduced federal grant amount. The GLO-funded portion includes paying for completion of a loop road, 2,000 extra in-ground plots for cremated remains and automatic gates. The combined federal and state funds allow for 21,546 interments.

To secure the federal grant prior to the end of the federal fiscal year (September 30, 2023), VLB staff immediately started the engineering design and statewide procurement process for the Cemetery's construction.

On July 24, 2023, following community input, the VLB Board voted unanimously approved the proposed Cemetery name as the West Texas State Veterans Cemetery. The VLB also voted to authorize the staff to execute a contract to construct the Cemetery.

On November 20, 2023, the VLB initiated the construction process, and the cemetery is scheduled for completion in November or December 2025.

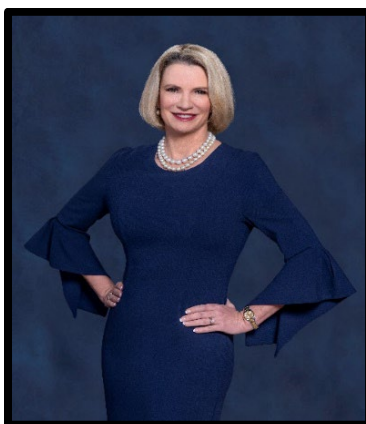

Judson Scott of Bee Cave is a retired attorney, judge, and rear admiral. He was appointed as a Federal Administrative Law Judge, ruling on cases for the Social Security Administration in their San Francisco, California hearing office.
